#### Code of Conduct

#### **Data Protection & Privacy**

Suppliers must process personal data in accordance with applicable laws and agreements with Mecan. Personal data shall be processed fairly and carefully. Suppliers must also comply with applicable cybersecurity laws and regulations, taking proactive measures to ensure the security of provided products, systems, and services. Suppliers must inform Mecan without undue delay about cybersecurity incidents impacting Mecan or products and services provided by the suppliers.

#### **Fair Competition**

Suppliers must strive for fair competition and comply with applicable competition laws. Suppliers must refrain from activities that might hinder fair competition, such as sharing price information or market shares with competitors.

#### **Conflicts of Interest**

Suppliers must avoid situations where a conflict of interest with Mecan might arise. They must inform Mecan of potential or actual conflicts of interest.

#### **International Trade**

Suppliers must comply with all applicable national and international trade restrictions and embargoes, as well as all applicable export and import laws and customs regulations.

#### **Monitoring and Auditing**

Suppliers must continuously monitor and document their compliance with this Code and applicable laws and regulations. Mecan reserves the right to verify suppliers' compliance with this Code through audits.

### **Declaration of Compliance**

The Vendor hereby represents, warrants, and certifies to Purchaser as follows:

- 2. The Supplier is familiar with, understands, and complies with the provisions of the anti-bribery and anti-corruption laws of the countries in which it conducts business. The Supplier commits to uphold these standards in all dealings and transactions associated with Mecan, ensuring full compliance with such legislation across all operations.
- 3. The Supplier will not offer, arrange for, or pay, either directly or indirectly, anything of value to a Government Official, political party, or a candidate for political office with the intent of inducing a Government Official to perform or fail to perform their official duties to assist the Supplier or Mecan in obtaining or retaining business, or in securing any improper advantage in connection with the deliveries to Mecan.
- 4. The Supplier declares that neither it, nor any of its executives or employees, nor its affiliates are under current criminal investigation or have been subject to any civil or criminal enforcement actions, at home or abroad, for improper conduct relating to bribery, corruption, or violation of the laws governing business corporate entities.
- 5. The Supplier agrees that if at any time the representations, warranties, and certifications herein, are no longer accurate and complete, the Supplier will immediately notify Purchaser and provide a supplementary report detailing such change.
